#### **UPDATE ON SITE WORK**

### Planings.

- Drew was hoping to deliver the planings in November, but due to weather and site conditions, he was unable to due to flooding.
- Possibly have the first 20T dropped near the crawler track, near the 1st shelter near the buggy track, which would make distributing the planings easier.
- We could be donated a further 20T, these would be delivered onto the top car park.

#### Tree Cutting.

- The work is starting on Wednesday 3rd December.
- Jack, the tree cutter has all access codes.
- An email has been sent out to all members who have provided email addresses.
- Jack will shred as much as he can but the larger logs can't be shredded.
- He will start in the top car park.
- 3T of wood chippings will be dropped near the 2nd shelter near the crawler hill so they can be used on the buggy track.
- 3T of wood chippings will be dropped near the railway, so they can be used near the track.
- More chippings could be dropped in the little car park.
- Larger logs will be set aside and any members who would like some for their log burners/home bonfire, they are more than welcome to collect some.
- Cost of the work is approximately £7200 plus Vat and £55 per tonne to dispose from the site.

- Val and Ann have been tidying up the plants.
- Moving plants in the railway area in preparation for the extension.

#### Railway Update.

- All trees are down behind the railway and have been shredded.
- Bigger logs have been taken away.

# The Environmental Protection (Wet Wipes Containing Plastic) (England) Regulations 2025 Overview of the Regulations

The Environmental Protection (Wet Wipes Containing Plastic) (England) Regulations 2025 prohibit the supply of wet wipes containing plastic to consumers in England. This legislation is part of a broader effort to reduce plastic pollution and its harmful effects on the environment and wildlife. The regulations define plastic broadly, including materials like polyester and polypropylene, and require manufacturers to use natural alternatives such as biodegradable viscose, cotton, or bamboo. This will come into force in a couple of years banning WET WIPES! Please take wet wipes home with you as they clog our pumps.

Pump 1 was checked and had stopped working, possibly a wipe had clogged it up, it was switched off and then started again, but was very slow. An eye will be kept on it.

The kettle in the member kitchen area is to be replaced due to it leaking.

The vermin boxes were checked last month and 1 box had the poison slightly nibbled, they were checked again on Sunday and all the poison had been eaten. Paul purchased more poison and the boxes have been refilled.

A box is to be placed near the charging shed near the pump house.

Trevor has requested a box in the covered area on the truck track.

The lawn mower is due a service, Paul is to contact Roger Bentleys to arrange for them to collect. The mower has had no problems but it requires a service to keep the guarantee up.

The Galley manager is looking forward to next years season.

Mike has asked Trevor to show a member who has 3D printed an excavator around the construction area. Maybe we will get more 3D printed machines onsite.

The corner view mirror on the road into the top car park is broken and needs to be replaced once the tree work has been completed.
